### **Town of Sorrento**

### **FOAA Policy Regarding Requests for Public Records**

- 1. If a citizen wants to inspect the records in person, the requester must make an appointment with staff at the Town Office for a time during office hours when it is convenient for the staff.
- Or requester can ask for copies to be made and mailed to them, (there is a fee for this).
- 3. A FOAA Public Records request form must be filled out, either by requester or by Town Office.
- 4. FOAA request do not require a reason.
- 5. Request form is kept in FOAA binder.
- 6. Town Office must acknowledge the request within 5 working days.
- 7. Request must be fulfilled in a "reasonable amount of time" based on the nature of the request.
- 8. A private citizen is not allowed to have unsupervised access to municipal records.
- 9. Records may not be lost, altered or damaged.
- 10. If your request requires a memory stick you must purchase one from the Town Office for \$5.00. You may not supply your own, as to prevent viruses as stated under government guidance.
- 11. State rules for copy fees are currently \$.10 per page, and for staff time over the first 2 hours are \$25 per hour. Fees may change.

# Town of Sorrento Select Board (SB) Meeting Minutes October 1, 2025 Community Building - 7 pm

Present: Hilly Crary, Rob Wilpan, Sue Macey, several observers.

- 1. Crary called to order at 7:00 PM.
  - a. Good News Report: Grant reimbursements received from FEMA and MEMA for the Ocean Avenue repair work for over \$900,000.
  - b. Bad New Report: Severe drought.
- 2. Minutes of September 17 and September 24, 2025. **Motion was made and seconded to** approve. **Motion passed: Crary aye, Wilpan aye, Macey aye.**
- 3 Disbursement and Payroll Warrants #7. **Motion was made and seconded to approve the payroll** warrant and to approve the disbursement warrant conditionally after checking with the auditor regarding the three charitable disbursements from prior years. Motion passed: Crary aye, Wilpan aye, Macey aye.
  - 4. Adjustments to the agenda. None.

#### **Unfinished Business:**

- 5. Update Ocean Ave : repairs/construction/steps/plantings/culvert. A motion was made and seconded to approve pavement restoration work on Ocean Avenue as recommended by Walsh Engineering for \$64,500 beyond the original contract amount. Motion passed: Crary aye, Wilpan aye, Macey aye.
- 6. Community Building updates. A motion was made and seconded to approve allocating \$1,400 for material from the repairs to town property account; these funds will be used to renovate the old furnace room in the Town Hall, converting it into a break room for the town staff. Motion passed: Crary aye, Wilpan aye, Macey aye. Dale is kindly volunteering to do the labor, free of charge.
- 7. Pollinator Meadow update. General discussion.
- 8. Abatements per auditor request. A motion was made and seconded to approve various property tax abatements for unpaid back taxes, as per auditor request, totaling \$7,974.12. Motion passed: Crary aye, Macey aye, Wilpan aye.
- 9. Board of Appeals appointment. The first organizational meeting will be October 8, 2025. Due to one member resigning, a motion was made and seconded to appoint Newbold (Terry) Noyes to the Town of Sorrento, Board of Appeals. Motion passed: Crary aye, Macey aye, Wilpan aye.
- 10. BlueHost mail server update. The Sorrento Town Clerk has requested an appointment to meet with Roy Gott, the Sorrento IT contractor, to review the use of BlueHost mail server for the town email and discuss alternatives. A motion was made and seconded to allow these discussions, with the possibility of a selectboard member joining. Motion passed: Crary aye, Macey aye, Wilpan aye.

#### New Business:

11. Agenda request from Susan Dougherty regarding Planning Board procedures, via **email** with subject 'REQUEST TO BE ON SELECT BOARD 10/1/2025 AGENDA PLANNING BOARD OPERATIONS AND PROCEDURES' dated 2025-09-22 from Susan Dougherty sent to Hilly Crary. A copy of the email can be found in the Town Correspondence File in the Town Office.

<u>Point 1:</u> Request mandatory FOAA training for all Planning Board (PB) members, and for the selectboard to review procedures regarding meeting and minutes with the PB.

Remediation: Hilly Crary will attend the 10/2/2025 PB and review FOAA requirements with the members. The Town of Sorrento tracks all FOAA training details applicable to the town.

<u>Point 2:</u> Legal counsel regarding quorum for PB if 3 members have to recuse themselves.

Remediation: Hilly will seek legal counsel regarding a few points. (1) A motion was made and seconded to allow Hilly to seek legal counsel for guidance on steps to be taken if the PB does not have a quorum due to recusals. Motion passed: Crary aye, Macey aye, Wilpan aye. (2) A motion was made and seconded to allow Hilly to seek legal counsel for a second matter; the purpose is to gain guidance on whether individuals who either wrote the letter soliciting donations to the Dougherty Legal Defense Fund or

donated to the legal fund need to recuse themselves when discussing Dougherty permits or other related matters. Motion passed: Crary aye, Wacey aye, Wilpan aye.

<u>Point 3:</u> PB and Town Code Enforcement Officer (CEO) to operate within their powers and duties as outlined in state and municipal ordinances.

Remediation: Hilly will attend the Oct. 2 PB meeting and review these policies with the board. The CEO will be attending.

<u>Point 4:</u> Comprehensive plan overview. Remediation: The plan is being submitted to the state. See #12 below.

<u>Point 5;</u> Policy for Legal Counsel. Remediation: Policy will be created that requires Selectboard approval before seeking legal guidance.

- 12. Comprehensive plan submittal form. The Comprehensive plan submittal form was signed by Hilly Crary and Ann Hoffner as requested by the Hancock County Planning Commission.
- 13. Ballot clerk appointments. A motion was made and seconded to approve the ballot clerk appointments for November 4th, 2025. Motion passed: Crary aye, Macey aye, Wilpan aye.
- 14. Citizen Petitions. Receipt acknowledged of 3 petitions.
- 15. Agenda request from B. Malmrose regarding the Community Building and the Pollinator Meadow. Not discussed as Mr. Malmrose was not present.

#### Public Comments on Agenda Items:


 There is a request from the public that voting on the Comprehensive Plan be timed and conducted in a way that allows for maximum public participation. This includes making provisions for absentee voting if possible. Board members agreed.

Motion to adjourn at 8:53 PM was made and seconded!!! Motion passed: Crary aye, Wilpan aye, Macey aye.

### **Dog Licenses**

\*\*Dogs must be licensed by January 1 of each year or when they reach 6 months of age. \$6 for neutered/spayed... \$11 for unaltered

\*\*Any dog living in the Town of Sorrento must have a **Sorrento** license/tag.



\*\*\*When licensing your dog, you must bring with you your dog's <u>rabies certificate showing the tag number</u> and <u>date of expiration</u> and your <u>certificate of proof of spay or neuter</u>, unless these are already on file at the Town Office.

Online licensing is available October 15 thru January 31 www.apps1.web.maine.gov

Starting February 1 a fine of \$25 will be due along with the registration fee on any unregistered dog. If you no longer own a dog that was registered last year, please call the Town Office to update our records.

#### **SULLIVAN HISTORY OF NOTE**

On November 20, 1798, the ship "Rachel" was lost off Cape Cod in a terrible storm. All of the men aboard drowned, and all were Sullivan men. The ship was built by John Simpson, and he was the captain. In our collections is a piece of art made by Simpson's grandson John S. Emery in 1878. It reads:

"This Tablet marks the burial place of Capt. John Simpson of Sullivan Maine, Aged 35 years, Master of the Schooner Rachel of that place, who, with his entire crew consisting of the following persons, viz.:

Paul D. Sargent, Jr. (passenger), William Abbott, Stephen Merchant, Zachariah Hodgkins, and James Springer, were all lost on the wreck of the above vessel near this place in the memorable snow storm November 20th 1798 and afterwards buried here."

### Due to ongoing traffic concerns on the Town of Sorrento roads

#### Rules and Regulations regarding golf carts on Maine public roads

Golf carts are not allowed on a public road that does not have conspicuous signs placed at regular intervals stating that the road is for golf cart access. These roads are only near golf courses or in areas with a large number of courses.

#### To drive on allowed low speed roads:

The cart must weigh less than 3,000 pounds, must be registered with the <u>local DMV</u> and operated by a licensed driver. This requires you to get the cart inspected to meet federal and state safety standards. At this point, you'll get a VIN and can register and license your cart. Upgrades that you need to add to your cart include windshields, seat belts, stop lights, turn signals, taillights, headlights, reflex reflectors, parking brakes, rearview mirrors, and more. These upgrades must be done according to state and federal law or they may be null and void.

Contact a local golf cart repair technician to upgrade your cart in this way.

#### **EXPIRATION DATES**

<u>VEHICLES:</u> Expire a year from when they are registered (unless you are transferring)

<u>TRAILERS:</u> Can be registered for 1 or 2 years, same month, except over 2000 lb.

Trailers expire in Feb. (1 or 2 years)

BOATS: Expire Dec. 31<sup>st</sup> ATVs: Expire June 30<sup>th</sup> SNOWMOBILES: Expire June 30<sup>th</sup> MOTORCYCLES: Expire March 31<sup>st</sup> of every year, except antique

### Sorrento Fire Department

#### **BURN PERMITS**

You are required by Maine law to have a permit to burn, even for a small pile of grass clippings or leaves. A Forestry Warden will be called if you burn without a permit, possibly resulting in you being summonsed to court and fined.

The person who signs the fire permit is responsible for the fire. Do not leave any fire unattended.

This online service allows you to request an open burning permit from 9am - Midnight, 7 days a week, provided that the fire danger is not high.

#### www.maineburnpermit.com

#### Required for burning:

- \*\*at least two adults to attend the burn,
- \*\*some form of water supply and hand tools must be on hand,
- \*\*and it is recommended you have a cellular phone or other communication device to call for assistance should the fire escape. YOU are responsible to see that the fire is out before leaving.

#### **TAKE NOTE**

#### **BURNING TRASH IS ILLEGAL!!**

State Laws (12 MRSA 9321-25) governing the backyard burning of household trash are enforced by the Maine Forest Service.

If you think someone is burning trash please call 973-3700 immediately! 24 hours/day, 7 days a week.

#### **ONLINE BURNING PERMITS**


Traditional hand-written burn permits are still available, but the state online system allows permits to be acquired 24 hours a day, seven days a week, throughout the state, provided that the fire danger is not high.
