#### **2022 Dog Licenses**

Starting February 1, 2022 a fine of \$25 will be due along with the registration fee on any unregistered dogs. If you no longer have a dog that was registered last year, please call the Town Office to update your records.

\*\*Dogs must be licensed by January 1 or when they reach 6 months of age.

\*\*\*When licensing your dog, you must bring with you your dog's <u>rabies certificate showing</u> the tag number and date of expiration and your certificate of proof of spay or neuter, unless these are already on file at the Town Office.

Greetings from RSU #24,

I hope this update finds each one of you ready for the warmer temperatures and the arrival of green grass and flowers (and bugs..ugh!). It is hard to believe that we have less than two months left before the school year ends.

We have established the end-of-year celebration dates for the schools/programs in the district. The Adult Education graduation ceremony will take place on June 13th at the Sullivan Gazebo. Class night at Sumner Memorial High School is June 7th and graduation is June 9th. Eighth grade promotion for Mountain View and Ella Lewis is June 13 while Peninsula and Cave Hill will have their promotion on June 14th. Our last day of the school year for students is Wednesday, June 15th. As you can imagine, there will be a great deal of emphasis on the end-of-year celebrations with the transition to the new building and the impact on our four K-8 schools. Although there is a great deal to be happy about regarding the transition, there is a lot of history in each building that should be remembered.

As part of our events to celebrate the old Sumner Memorial High School, The Last Dance will be held on Saturday, May 14th from 6:00 to 10:00 p.m. There will be a dinner (\$10/person) served in the cafeteria at 5:00 p.m. and the dance (\$30/person) will take place in the Clint Ritchie Gymnasium. Whiskey Bent will be playing live music and the dance is open to Sumner Alumni and their partners. Reservations are suggested and can be made by calling the school at 422-3510. Proceeds will benefit the new building.

The RSU #24 Finance and Budget Committee has completed its review of the RSU budgets and approved forwarding the budgets to the full Board at its May 3rd meeting. This was a time intensive process that took us into uncharted territory. With the expenses associated with the new Charles M.

Sumner Learning Campus and the state of our economy, it was a challenge to put a budget together. The full Board will consider the Adult Education budget, pre-K to 12th grade operating budget, and whether to provide access to "reserve" money set aside for the opening of the new building. The specifics of each budget will be posted on the RSU #24 website prior to the May 3rd meeting. Once the budget is approved by the full Board, we will move to the District Budget Meeting. The District Budget Meeting will take place on May 25 (6:30 p.m.) in the Sumner Memorial High School gymnasium. At this meeting, the budget will be presented and several required votes will be taken.

## Selectmen Meeting Minutes 3/16/2022

Attending via Zoom were Rob Wilpan, Jon Mickel, Craig Clement, Kathi Moore, Joey Clark, Dan Dougherty, Susan Clancy-Dougherty, Diana Gazis, Tom Bailey, Mason & Darla Crocker. The meeting was called to order at 7:02 p.m. by Rob Wilpan.

GUEST SPEAKER ON AQUACULTURE MORATORIUM: A presentation was made by Crystal Canney, Executive Director of Protect Maine's Fishing Heritage Foundation. She spoke briefly about the increasing number of aquaculture leases since 2011 without the resources to oversee them. Their legal team put together a model 180-Day Moratorium on Aquaculture Development as a baseline for municipalities and they can modify it as needed.

MINUTES: Rob read the 3/02/2022 minutes and amendments were made. Rob made a motion to approve

amendments were made. Rob made a motion to approve the minutes as amended, seconded by Jon, unanimous vote, motion passed.

**UPDATE ON COMMUNITY BUILDING BOILER:** Jon reported that Steve is still working on quotes and his recommendations for upgrades. He did say that we can leave the vent open a crack.

UPDATE ON PIER DESIGN: Rob reported that Mike said legally we don't have to abide by the 4" sphere maximum openings for new pier but it's quite open and we need to do something. Henri quoted \$6,000 to string stainless steel cable and attach to the sides, including aluminum balusters. Mike suggested using lobster mesh, not sure how to attach or what it would look like. Discussion. Color options for lobster mesh are white or gray. All Selectmen agreed this would look best, Rob will get prices. Rob met with Tony Atwater about proposals for adjusting the height of the approach of the pier, he is working on that.

**UPDATE ON GANGWAY MAINTENANCE**: Rob reported that Jon provided the WCBY estimate for gangway repairs of \$2405. Rob made a motion to approve the work as quoted, seconded by Craig, motion passed. Jon abstained from the vote.

#### **UPDATE ON FRENCHMAN BAY MONITORING PROJECT**

**GRANT**: Rob reported that Frenchman Bay United donated \$1000.

**UPDATE ON FIRE DEPARTMENT OFFICE ELECTRICAL:** Joey said he checked again with Donnie Lee and he is still swamped, we are on his list.

**UPDATE ON STATE SURPLUS FUNDS (DONEE):** Joey reported that the paperwork has been submitted and the new cards are in the mail.

**UPDATE ON PROPANE GAS DETECTOR**: Rob suggested

having Seacoast Security install a detector that's wired into the system. Kathi offered to call them to order this. **UPDATE ON STREET SIGNS**: Jon forwarded an email to Rob. Craig, Joey and Kathi that he received from Alan Farrington, DOT Traffic Engineer, outlining the DOT findings & recommendations. The DOT concurs that the sight lines are short and barring some very expensive realignment of the intersection, they agree that an all-way stop is the best option with the resources available. The DOT will be ordering an LED solar powered flashing STOP sign to install on the North approach of Sorrento Ave; they will install allway STOP signs (in addition to the current stop signs); STOP AHEAD signs on Sorrento Ave & Kearsarge and left side of the road STOP signs on Sorrento & Kearsarge. With visibility concerns, they'd like the Town to cut back the vegetation on the North side of Kearsarge for better visibility for traffic on Kearsarge, vehicles entering the roadway from the Spain residence and visibility through the intersection for vehicles on Waukeag. Also they requested the immediate removal of the Dangerous Intersection signs due to liability concerns. Jon is to contact Randy Spain to set up a meeting with Joey

- 1) Jon made a motion to remove the Dangerous Intersection signs as soon as possible, seconded by Rob, unanimous vote, motion passed.
- 2) Jon made a motion to respond to Alan Farrington at DOT approving his plan of remediation with the only contingency being the vegetation issue that needs further discussion, seconded by Rob, unanimous vote, motion passed.
- 3) Jon reported that we recently purchased a fixed solar radar sign to try to improve the safety of this intersection and with this proposal the sign will not be needed so Jon made a motion to return the sign to the vendor and if for some reason that is not possible then we offer the sign for sale, seconded by Rob, unanimous vote, motion passed.

UPDATE ON WAUKEAG STORM DRAIN PROJECT: Rob reported that Annaleis from Olver Associates has been working on the project for improving the drainage along Waukeag Ave and removing storm water from the sewer system. The cost of the project she is applying for is \$275000 so we will see what will happen with the funding. If we don't get 100% funding we don't have to accept it, or possibly there are other grants that will cover the difference.

**UPDATE ON FIRE DEPARTMENT BOAT**: Jon reported that Harbor Master Lou Sutherland has a mooring available for the Fire Department's boat for \$500. It is located right in front of the dock. Jon made a motion to take Lou up on this \$500 mooring, in as is/where is condition, seconded by Rob, unanimous vote, motion passed. Jon said he will follow up with Lou.

#### **NEW BUSINESS:**

Kathi reported that the most recent No Frill's Oil statement reflects that in one month the Community Building used 410 gallons of oil, so there is \$474 remaining on our pre-paid contract for that building. Craig said that something needs to be done about the front doors. Dwayne was over there today and the bottom of the door was popped out so there was a gap. There was a discussion about winterizing and closing the building down for the winter in the future. The Fire House used 244 gallons in one month and there is \$254 left on that prepaid contract.

Joey brought up that we are very close or have gone over the threshold of \$5/gallon for diesel fuel. Rob said it's in the contract that out of surplus we pay that difference.

Joey reported that there is an issue with people dumping trash along Fuller Road. He has received several complaints and checked it out; there was a crib, paint cans, mattress, and pillows alongside the hill from the salt/sand shed. He had Josh Trundy pick up stuff the other day; it's getting out of hand. Joey suggested putting up a game camera in the area to find out who is doing it. Rob said the Town has 2 of them; they just need batteries and memory cards. The other Selectmen were in agreement. Rob is to get the cameras to Joey and Joey will set them up.

At 7:50 Rob made a motion to adjourn, seconded by Jon, unanimous vote, motion passed.

### Sorrento Fire Department



FOR BURN PERMITS ANY TIME OF THE YEAR: You are required by Maine law to have a permit to burn, even for a small pile of grass clippings or leaves. A Forestry Warden will be called if you burn without a permit, possibly resulting in you being summonsed to court and fined.

The person who signs the fire permit is responsible for the fire. Do not leave any fire unattended.

#### Required for burning:

- \*\*at least two adults to attend the burn,
- \*\*some form of water supply and hand tools must be on hand,
- \*\*and it is recommended you have a cellular phone or other communication device to call for assistance should the fire escape.

YOU are responsible to see that the fire is out before leaving.

#### **FIRE PERMITS**

Commercial burn permits are available
October 15 thru April 15.

Regular burn permits are available year-round.

Current conditions require rain for a permit to be issued.

#### TAKE NOTE

#### **BURNING TRASH IS ILLEGAL!!**

State Laws (12 MRSA 9321-25) governing the backyard burning of household trash are enforced by the Maine Forest Service.

If you think someone is burning trash <u>please call</u> <u>973-3700</u> <u>immediately!</u> 24 hours/day, 7 days a week.

#### STATE BURNING PERMITS

Traditional hand-written burn permits are still available, but the state online system allows permits to be acquired 24 hours a day, seven days a week, throughout the state, provided that the fire danger is not high. These you pay for. You don't pay for burn permits issued by the below fire department members.

#### May is Deck Safety Month

Each year, the North American Deck and Railing Association (NADRA) raises awareness about the importance of checking your deck by promoting National Deck Safety Month. Homeowners can take advantage of resources and tools from the NADRA webpage (nadra.org) to ensure the safety, security and longevity of their decks. Also, a 10-Point Deck Safety Checklist is available at the Sorrento Town Office. The checklist provides a step-by-step guide to visually inspecting the deck for safety concerns such as corroding fasteners, decaying materials, loose railings, inadequate lighting, and more. The checklist is a helpful tool to assist homeowners. The Code Enforcement Officer is available to discuss decks and other possible safety concerns around your home. #### **Permits and Fees**

The Town of Sorrento requires that anyone performing plumbing or construction to submit an application and pay for permits. Applications will be reviewed and permits issued by the Code Enforcement Officer. Common projects that require permits include plumbing renovations, repairs and additions, septic systems, driveways, fences, signs, building construction and shoreland projects. The Town enforces the 2021 Uniform Plumbing Code, as adopted by the State of Maine, and the Maine Subsurface Wastewater System Rules. Plumbing projects, both internal and external, require inspections by the Code Enforcement Officer. Inspections may be

scheduled through the Town Office. A schedule of Permit Fees is available at the Town Office.

#### Reminders

- No work is to be started until your permit is issued; starting work before a permit is issued may result in fines.
- All contractors doing soil work in the shoreland must have State Certification and must furnish a copy to code enforcement for every shore project.
- No subsurface wastewater systems (septic) may be installed in frozen ground or when the ambient air temperature is below freezing.
- All construction must comply with the Maine Uniform Building & Energy Code as well as the 2020 National Electric Code, the 2021 Uniform Plumbing Code and other applicable state and local rules, ordinances, codes and regulations.
- Many properties in the Town of Sorrento fall into Shoreland Zone and have a specific ordinance that must be complied with for any construction, alterations, etc. Shoreland is generally considered as any area within 250 feet, horizontal distance, of the upland edge of a coastal wetland, including all areas affected by tidal action; and within 250 feet, horizontal distance, of the upland edge of a freshwater wetland.


